6:00 P.M. REGULAR MEETING

Board President Lincoln Forry called the Regular School Board Meeting to order at 6:00 p.m. Members present were Terry Bressler, Lincoln Forry, Cindy Steidlmayer, Charles Yerxa and Don Bransford. Others in attendance were Superintendent Larry Yeghoian, Principals McGrath, Tarr and Johnston, Business Manager Sheryl Bailey, teachers, staff and students.

STUDENT'S REPORT

CHS student representative MacKenzie Bressler reported on activities taking place at Colusa High School. She reported that on May 2 the Leadership class is having a World Fair. Each class is picking a country and having a food or game from that country.

PRESIDENT'S REPORT

Board President Lincoln Forry reported he has had several calls from parents. Is there anything we can do about the traffic congestion at Egling Middle School? Traffic is very bad, especially on rainy days. Is it possible to get help from the police dept.?

Another question asked of him by a parent was when do counselors step in when a student is failing? A parent expressed a concern that their child was failing and they had no idea it was happening. Erika Lemenager spoke about the process at Egling.

Assign Board Committees President Forry asked the board members if they wanted to maintain the same committee assignments they've had in the past. SUPERINTENDENT'S REPORT

- Mr. Yeghoian stated he would like to have the Board host a reception for the new Superintendent, Dwayne Newman and his wife the afternoon of April 16, possibly from 4 p.m. – 6 p.m. so staff and community can meet them. The Board was in favor of the date.
- Mr. Yeghoian reported EMS & CHS music teacher Mike Phenicie was one of the top 5 finalists in the State for the CTA Award of Excellence. He did not win the award but it was a very high honor to be in the top 5. The winner of this award is entered for National recognition. The Board would like to honor Mike at the next Board Meeting in April.

- CHS Principal Dave McGrath gave his school report. He stated March 28 is Open House and 8<sup>th</sup> grade parent information night. April 2 is the Super 7 Dinner, April 16-20 several CHS students will be counselors at Shady Creek. Butte College and Woodland Community College have scheduled events for CHS seniors. Many seniors have received acceptance letters from colleges and these letters are on display in the Counseling Office. Valedictorian is Haley Prasad and Salutatorian is Elaisa Ramirez. The Vern Regier Track Meet will be held at Yuba College and they are currently recruiting students for Upward Bound Programs. TOP Career Technical Education (CTE) performed a visit to CHS similar to a WASC visit about ROP and CTE programs. CHS was given high marks!
- Mr. Yeghoian stated CHS would like to change the name of the Food Technology Course that was adopted at the February board meeting. The course was approved as an elective but CHS is seeking approval from CDE to approve the course as a Chemistry class. The new name of the course would be AG Chemistry. A discussion was held, and it was decided an action item will be placed on the April agenda to reflect the name change.
- Mr. Yeghoian stated he needed two board members to be on the new CHS principal interview and screening panel. Don Bransford, Terry Bressler and Lincoln Forry volunteered. Mr. Yeghoian will work with them to choose 2 board members depending on the dates.
- Mr. Yeghoian reported on the East Clay Housing Project. He will try to attend tonight's Colusa City Council meeting to express the School District's concerns. He has delivered the attached report to the City Council.
