6:00 P.M. CALL TO ORDER

The regular board meeting of the Colusa Unified School District Board of Trustees was called to order at 6:00 p.m. in the District Office Conference Room by Board President Don Bransford, and established a quorum was present. Board Members present were Terry Bressler, Lincoln Forry, Charles Yerxa and Don Bransford. Board Member Cindy Steidlmayer was absent. Also in attendance were Larry Yeghoian, District Superintendent; School Administrators Dave Tarr, Jody Johnston and Dave McGrath; staff members and parent, Daniel Bailey.

STUDENT'S REPORT

Nohemi Padilla and Katelyn Mena reported on activities at Colusa High School that included student body elections, sporting events, Cultural Week, students' trip to Ashland and senior projects.

PRESIDENT'S REPORT

- During Board of Trustee time Mr. Bressler congratulated the high school girls' soccer team for being Northern Section champions for the 3rd year in a row.
- President Bransford asked what district committee board members would like to serve on. They agreed to the following: Lincoln Forry and Terry Bressler - Stadium and Friends of Ag.; Charles Yerxa - CRAF; Don Bransford -Friends of Music; and since Cindy Steidlmayer had enjoyed being on the SELPA Committee in the past, Mr. Yeghoian thought she would like to continue to be on that committee for the 2011-2012 school year.
- President Bransford polled the board for a date and time for the April Board meeting. It was determined that April 12, 2011 would work for all. The meeting will start at 4:30 p.m. for the Tenured Teacher Reception, adjourn for the Action Team meeting at 5:00 p.m. and reconvene the Regular Board Meeting at 6:00 p.m.

SUPERINTENDENT'S REPORT

- Dave McGrath gave a CHS/CAHS review. He thanked Gay Seaver for putting up the Conference Room bulletin board. He stated the WASC accreditation that was held February 27 through March 2 went very well, and the school will know by June if they will continue to be accredited for the next 6 years. Mr. McGrath reported students were doing very well in their competitions throughout the student body clubs. He stated there were 11 State Farmer degrees awarded; the ESA students placed 3 teams in the top 10 when they entered the Caring for Water Sheds competition; there were 19 awards given to students at the State Music competition, 2 students, Lupita Ramos and Efrin Fuentes, were selected Best in Category; Taylor Davies was elected secretary for the North Section FBLA; and CIF awarded the **Spirit of Sport Award** to Mimi Rinzler.
- In his Report of the District Superintendent Mr. Yeghoian reported on the status of the Stadium Restroom Project that is sponsored by the Colusa County Supervisors grant funding. He stated the portable restrooms had

- been ordered and the architect is working on approval letters from the Division of State Architect's office.
- Mr. Yeghoian reported there were three different campus beautification projects in the planning stages for this spring at two school sites. The CHS Quad and Campus Beautification Projects are under the lead of parent Lisa Bailey. This project will enhance the landscaping at CHS. The CHS Stadium Project is being supported by parents who would like to participate in the landscaping of the stadium, as well as concrete work between the concession building and new restroom facility. The last project is at Burchfield Primary School. The BPS Parent Club has initiated a project to paint the blacktop areas in different themes and activities. Parents, students and community agencies will be involved with various aspects of the project.
- Mr. Yeghoian reported the Governor is still seeking support for a budget deal
 that includes placing a tax extension on the June ballot. He stated CUSD's
 budget projections for 2011-12 have been made without a tax extension
 passing. Until a budget deal is reached, the district does not know what the
 final impact will be to our budget.
- Mr. Yeghoian reported that UPS will start using the district's 5th Street "Bag Works" facility on April 1.

CEA REP'S REPORT

Bobbie Weiglein stated 2 teachers from CEA had attended bargaining training in Yuba City. They are very grateful there have been no pink slips issued in Colusa.

CSEA REP'S REPORT

Rosemary Hicks said there will be a general chapter meeting of Colusa's CSEA members next week.
