- Federal Program Monitoring (FPM) Update Mr. Newman reported on the FPM training that took place in Sacramento. The process will be time consuming but appears to be very straight forward.
- Staff Survey Results Survey responses were positive. Mr. Newman and Administration will use the information from the surveys to determine upcoming professional development opportunities.

Rebecca Changus reported on the CHS Summer School program. Ms. Changus stated that the collaboration which occurs between the CHS teachers & the Summer School teachers, results in a curriculum that is rigorous and in line with common core instruction. Two independent study courses were offered this past Summer which in turn allowed for one on one support for students. Support classes are offered to students that struggle in certain subjects and are identified by the counseling office.

Rosemary Hicks reported that CSEA will be meeting again on December 11, 2015 to go over job descriptions. They are hoping to complete that process and have it ready to be presented at their next negotiations.

CEA REPORT

Bobbi Weiglein reported that the tentative agreement was ratified at their last meeting. CEA is reviewing some of the contract language as it relates to how the parent-teacher conferences are being done. CEA is hoping to be able to have more student testing take place prior to the meetings in hopes that it will provide parents/guardians with a more in depth view into their child's academic progress. In addition, CEA will be looking at various options for professional development as well language to include into the contracts specifically relating to signing bonuses for hard to fill positions.
