Mr. Brown recognized Terry Biladeau for his work at CUSD and for creating an atmosphere that has built confidence throughout the district. Jamie Lay was also recognized by Mr. Brown for his hard work.

SUPERINTENDENT'S REPORT IMPROVING ACHIEVEMENT

- Reminder to Board for School Site Visits Mr. Newman encouraged the Board to plan and schedule their visits to the sites.
- Smarter Balanced Assessment Consortium (SBAC) Results Mr.
   Newman presented information on how CUSD students performed on the SBAC testing. He was pleased to announce that CUSD performed very well. Test results showed that the District met most of its goals for improved overall student achievement and for closing existing achievement gaps.

SUPERINTENDENT'S REPORT MANAGEMENT

• Bond Projects Update – The Citizens' Oversight Committee will meet again later in October. CPM provided an update on Proposition 39 California Clean Energy Jobs Act. CUSD is likely to see a savings of approximately \$65,000 in energy savings. That savings will be slightly offset by the costs associated with running the A/C unit that will soon be installed at CHS. However, the savings will still be substantial. There are

past projects from the early 1990's that were not closed out with DSA. In order for any new projects to be closed out, DSA is requiring that past projects be closed out. This is a fairly new protocol for DSA. CPM is working diligently to close out those past projects for CUSD. Mr. Newman confirmed that an additional Board Meeting on October 27, 2015 will be held to discuss bond activity.

• Need for Maintenance Technician - Mr. Newman asked the Board for their direction in adding a Maintenance Technician/Bus Driver to the budget. The Board stated that they are comfortable with the additional cost and Mr. Newman will move forward with the process.

SUPERINTENDENT'S REPORT BUDGET

Enrollment – Mr. Newman reported that our enrollment numbers are holding steady and our attendance is comparable to that of last year.

PRINCIPAL'S REPORT

Mr. Brown presented information on Colusa Alternative Home School. Information on the enrollment process and program was given. Mrs. Roberta James shared that the vocational education requirement was expanded to include some exciting on the job training at a local business. Some of the skills students are learning include: how to use a Point of Sale system, balancing a register, maintaining inventory and customer service.
