This project will provide a significant energy reduction while greatly improving the overall quality and quantity of light. Selected recessed troffer fixtures are to be retrofit with 22W and 36W LED kits. The balance of fixtures with T8 linear 32W fluorescent lamps are to be replaced with 14W LED lamps and new compatible ballasts. Occupancy sensors are to be installed in required spaces per Title 24 requirements. All discolored or broken lighting diffusers encountered during this project will be replaced as part of this project.
