On behalf of the Trustees and myself, I would like to express our gratitude for the commitment, dedication and perseverance of the task force, which consisted of parents, teachers, classified staff, site administrators, the bilingual community/parent liaison and officials from the Colusa County Public Health Department, the local fire department and the County Office of Education as they explored, evaluated, and developed recommendations that will guide the District's school reopening plans.

As a reminder to Colusa Unified School District parents, as a result of Governor Newsom's mandate that schools located in counties that remain on the [county watchlist](#) must begin the school year providing distance learning to its students, the District's schools will begin the year providing distance learning on opening day, which is August 19th.

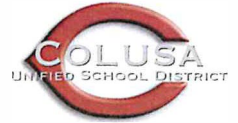
